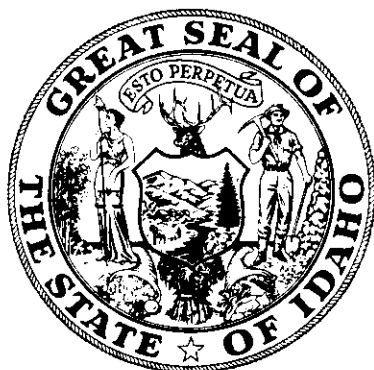

Pursuant to the provisions of Section 30-327, Idaho Code, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is VALLEY ICE ASSOCIATION, INC.

SECOND: Section 8 of the original articles of incorporation is deleted in its entirety and the following is substituted in lieu thereof:


