ARTICLE ONE

The name of the corporation is TREASURELAND VENTURES, INC.

ARTICLE TWO

The purposes of the corporation is to engage in any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The period of duration of the corporation is perpetual.
