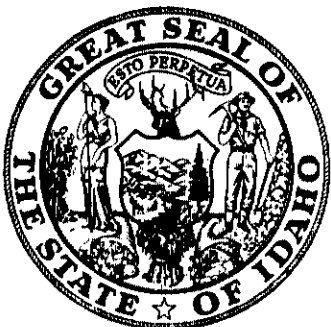
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is CORNERSTONE ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the Corporation is organized is to engage in the business of photography and any other business which a corporation may engage in under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of common stock with a \$1.00 par value.
