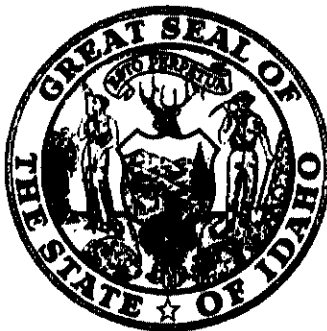
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
QUALITY AMMUNITION, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of this corporation is QUALITY AMMUNITION, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any and all other lawful business for which corporations may be incorporated within the State of Idaho.

FOURTH: Capital stock shall be TWO HUNDRED FIFTY THOUSAND DOLLARS. The aggregate number of shares which the corporation shall have authority to issue is two hundred fifty thousand (250,000) shares at a par value of one dollar (\$1.00).

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: There shall be a restriction on the transfer of any interest whatsoever of the stock of this Corporation. Restriction on the transfer of interest shall be governed by provisions as set forth in the By-Laws.

SEVENTH: The address of the initial registered office of the corporation is 1416 Eastridge Drive, Pocatello, Idaho

83201, and the name of its initial registered agent at such address is Emery G. Webster.

EIGHTH: The number of directors consisting the initial Board of Directors of the corporation is three (3), and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

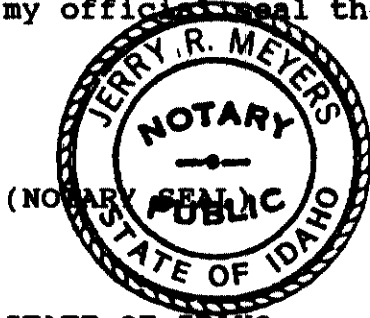

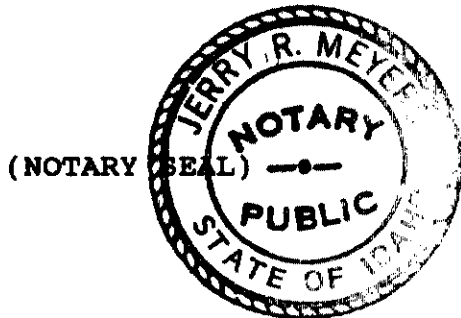
