
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF  
TRIPLE "A" LAWN CARE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

I. NAME

The name of the corporation is TRIPLE "A" LAWN CARE, INC.

II. DURATION

The corporation shall conduct business in perpetuity or until dissolved.

III. PURPOSE

The purpose or purposes for which this corporation is organized are the care and maintenance of lawn related services and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV. STOCK

The aggregate number of shares which this corporation shall have the authority to issue is One Thousand (1,000) shares common voting stock at \$100.00 per share, par value.

V. PRINCIPAL PLACE OF BUSINESS

AND REGISTERED AGENT

The address of the initial registered office of the corporation is 1377 W. Quinn Road, Pocatello, Idaho 83202, and the name of its initial registered agent at such address is LaMont W. Short.

## VI. INITIAL DIRECTORS

The Board of Directors of the corporation shall consist of one (1) or more members, unless otherwise modified from time to time by the Bylaws of the corporation. All directors shall be elected annually in accordance with the provisions of Idaho Code 30-1-36. There shall be no classification of directors or staggering of their terms.
