ARTICLES OF INCORPORATION

In compliance with the requirements of Section 30-323 of the Idaho Code, the undersigned, in order to form a non-profit corporation for the purpose of constituting a Free Methodist Church and for the other purposes hereinafter stated, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be NEW HEIGHTS CHRISTIAN FELLOWSHIP, INC. Hereinafter, said corporation shall be referred to as the "Church."

ARTICLE II

PRINCIPAL OFFICE

The initial principal office of the Church shall be located at number 8475 Midland Road in the city of Boise, Idaho. The initial registered agent at said address shall be DEAN JENKINS.

ARTICLE III

PURPOSE OF THE CHURCH

The purposes for which the Church is formed are religious, charitable, and educational in nature. In particular,

the Church shall conduct religious services, cultivate social intercourse among its members, and insist on improving and ameliorating the moral and social conditions of humanity. The Church may purchase, own, sell, dispose, mortgage or, lease real estate or other property as may be necessary for the purposes of this corporation. The Church shall also receive donations, receive, manage, take, and hold real and personal property by gift, grant, devise, or bequest, and sell or dispose of the same, and do everything necessary, suitable, or proper for the accomplishment of any of the purposes herein enumerated, or which shall at any time appear conducive or expedient for the protection or benefit of this corporation. In addition, the Church shall carry on any other activities for which a non-profit corporation may be formed within the state of Idaho.

ARTICLE IV.

MEMBERSHIP

Only persons who have qualified for preparatory, junior, or full membership in the Church pursuant to the *Book of Discipline of the Free Methodist Church of North America* shall be regarded as members of this corporation.

ARTICLE V

VOTING RIGHTS

Only full members shall be entitled to vote upon the affairs of this corporation. Preparatory members and non-members

who may be associated with the Church shall not be permitted to vote upon matters effecting the corporation.

ARTICLE VI

MANAGEMENT OF THE CORPORATION

The affairs of the Church shall be managed by an administrative council elected by the full members of the Church. The initial administrative council shall consist of the twelve (12) members whose names and addresses are set forth below. After the filing of these Articles, the size of the administrative council may be changed from time to time by the enactment or amendment of an appropriate bylaw in the matter set forth in the corporation's Bylaws. A quorum shall consist of a majority of the members of the administrative council.

ARTICLE VII

DISSOLUTION OF CORPORATION

The corporation may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of the members of the Church. Upon dissolution of the corporation, other than incident to a merger or consolidation, the assets of the corporation shall be transferred or dedicated to an appropriate non-profit agency to be used for purposes similar to those for which the corporation was created. No part of the assets of this corporation shall inure to the benefit of any member.

ARTICLE VIII

MEMBERS OF INITIAL ADMINISTRATIVE COUNCIL

ARTICLE XI

AMENDMENTS

Amendments to these Articles may be enacted only in conformity with the provisions of Section 30-326 of the Idaho Code. The Bylaws of the Association may be amended by the vote of two-thirds (2/3) of the members of the administrative council or by the vote of two-thirds (2/3) of the full members of the Church in accordance with Idaho law.

IN WITNESS WHEREOF, for the purpose of forming this corporation under the laws of the state of Idaho, the undersigned executes these Articles of Incorporation on this 25 day of April, 1993.

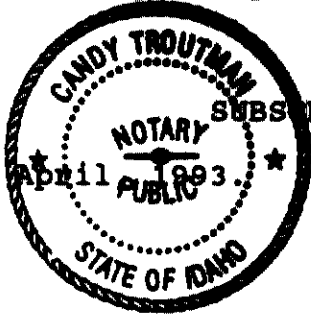
