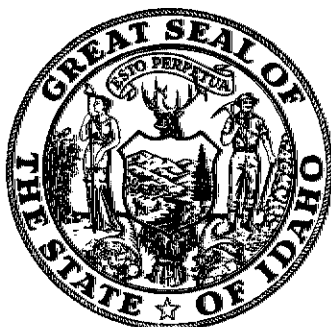

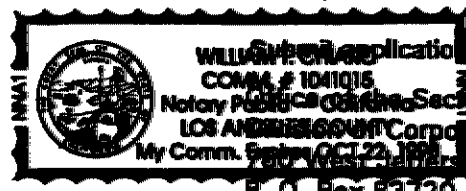
1. The name of the corporation is NME PSYCHIATRIC HOSPITALS, INC.
