ARTICLES OF INCORPORATION

OF

KIDDIE KORNER, INC.

WE, the undersigned, being natural persons of full age and citizens of the United States, or of its territories or possessions, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation.

I.

The name of the corporation shall be KIDDIE KORNER, INC.

II.

The corporation is not being organized for pecuniary profit, and no part of its income shall be distributable to, or otherwise inure to the benefit of its members, directors or officers.

III.

The period of its duration is perpetual.

IV.

The object, business, and purpose of this corporation is for the non-profit, non-political conduction of an educational facility aimed at the instruction and enjoyment of young children; to uphold and maintain high health and safety standards of care to and for children; for the implementation of a total development program of perceptual, social-emotional, and intellectual development, thereby encouraging individuality, creativity, imagination, education, school readiness, cooperation, and ambition in young people; and to carry out to the best interests of all children the proper conduct of society, health, and nature; and to do any and all things to this end as may be and are permitted under the laws of the State of Idaho and the Constitution of the United States of America.

V.

Membership in this corporation shall be open to all interested persons, and the rights and privileges of membership shall be fully set forth in the by-laws of this corporation.

VI.

The location and mailing address of the initial registered office of this corporation shall be 1525 Main, St. Maries, Idaho 83861, and the name of its initial registered agent at such address is David B. Corkill.
