ARTICLE VII: Dissolution Provisions

Should this corporation dissolve, it shall continue its corporate existence but shall not carry on any activities except those appropriate to wind up and liquidate its affairs, including:

- preserving and protecting its assets and minimizing its liabilities
- discharging and making provisions for discharging its liabilities and assets.
- abide by the precepts pursuant to sections 30-3-109 through 30-3-115 of the Non-Profits Corporation Act of the Idaho Code.

No distribution of corporate funds shall at any time be made to members either upon dissolution or otherwise. This prohibition, however, shall not prevent the corporation from reimbursing members for actual expenses incurred by them in the operations of this corporation.

Upon dissolution of this corporation, after payment of all liabilities and after such reimbursements have been made, the Board of Directors shall dispose of all assets of the corporation. Those assets will be distributed exclusively for the purpose of which this corporation was formed and in such manner or to such an organization or organizations, which are presently engaged in Search and Rescue work, and which shall at that time qualify for exemption under Section 501(C)(3) of the Internal Revenue code of 1954, preferably and American Rescue Dog Association unit.




ARTICLE VIII: Corporate Management and Regulation
