*Articles of Amendment and Restatement (Non-profit)*

To the Secretary of State of Idaho:

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends and restates its articles of incorporation as follows:

**Article I. Name**

The name of this church shall be Bellevue Community Church, Inc.

**Article II. Purpose**

The purpose for which the corporation is organized is for worship, nurture, fellowship, home and foreign missions, service, Christian education.

**Article III. Business Location**

The street address of the registered office is 309 Cedar Street, Bellevue, Idaho 83313 and the registered agent is Thaddaeus M Walton.

**Article IV. Board of Directors**

The board of directors shall consist of no fewer than (3) people. The names and addresses of the directors are:

**ARTICLE VII:** The corporation does have voting members

**ARTICLE VIII.** In the event of liquidation or dissolution of the church, all current and long-term obligations of Bellevue Community Church will be paid first. All of its remaining physical, non-monetary property of every nature and description whatsoever, except the parsonage at 317 E Cedar St. shall be deeded to and/or transferred to the following entity: The Christian church meeting regularly in the facility at 309 E Cedar Street, Bellevue, Idaho providing that that ministry is true to the Christian faith, has the financial strength to assume the responsibility of the facility, and has the will to continue church ministry in Bellevue. The first ministry to be evaluated on that basis is Iglesia Bautista Fundamental Independiente. Secondly, all remaining monetary funds shall be directed to one or more Christian organizations qualified under Section 501(c)(3) of the Internal Revenue Code for the benefit of Bellevue Community Churches supported missionaries and/or such other Christian endeavors as the members determine. The church will be considered dissolved if so decided by the congregation, or when less than six members remain.

The parsonage at 317 E Cedar St. will be dispositioned at the discretion of the voting members.
