AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

BEAR LAKE VALLEY CRIME STOPPERS, INC.

WHEREAS, the members of the BEAR LAKE VALLEY CRIME STOPPERS, INC., met on the 21st day of October, 1983; in a special meeting called for the purpose of amending the Articles of Incorporation of the BEAR LAKE VALLEY CRIME STOPPERS, INC.

WHEREAS, more than 75% of the members of BEAR LAKE VALLEY CRIME STOPPERS, INC., did meet on said date; and

WHEREAS, the meeting was duly conducted in conformance with the By-Laws of the corporation.

NOW, THEREFORE, the undersigned, as the President and Secretary, respectively, of the BEAR LAKE VALLEY CRIME STOPPERS, INC., do hereby certify that the following Article was voted upon by the membership of the BEAR LAKE VALLEY CRIME STOPPERS, INC., and more than 75% of said members approved amendment of Article III to read as follows:

ARTICLE III

PURPOSE

This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The purposes for which Crime Stoppers is founded are to promote community welfare and lessen the burdens of the government of the

county of Bear Lake by assisting the Bear Lake Valley police officers in the apprehension and conviction of criminals through making funds available for use in offering rewards; by helping develop a community offensive against crime; by motivating members of the public to cooperate with the Bear Lake Valley police officers and other law enforcement agencies in the surrounding area; and by providing for rewards and awards for such cooperation.

NOW, THEREFORE, the undersigned, as the President and Secretary, respectively, of the BEAR LAKE VALLEY CRIME STOPPERS, INC., do hereby further certify that the following Article was voted upon by the membership of the BEAR LAKE VALLEY CRIME STOPPERS, INC., and more than 75% of said members approved amendment of Article IX to read as follows:

ARTICLE IX

DISSOLUTION

BEAR LAKE VALLEY CRIME STOPPERS, INC., may be dissolved upon the affirmative vote of two-thirds (2/3) of the members of BEAR LAKE VALLEY CRIME STOPPERS, INC., taken at a meeting of the members called for that purpose, or upon the written consent of all members of BEAR LAKE VALLEY CRIME STOPPERS, INC., entitled to vote thereon. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code. Further, upon the dissolution or other

termination of BEAR LAKE VALLEY CRIME STOPPERS, INC., no part of the property of BEAR LAKE VALLEY CRIME STOPPERS, INC., nor any of the proceeds thereof, shall be distributed to or inure to the benefit of any of the members of BEAR LAKE VALLEY CRIME STOPPERS, INC., but all such property and proceeds shall, subject to the discharge of valid obligations of BEAR LAKE VALLEY CRIME STOPERS, INC., and to applicable provisions of law, be distributed as directed by the Board of Directors of BEAR LAKE VALLEY CRIME STOPPERS, INC., to or among any one or more corporations, trusts, community chests, funds or foundations described in Section 501(c)(3) of the Internal Revenue Code or any successor provision.
