**Block 4:** Enter names and business addresses of management. **Note:** Putting "same as last year" or "same as above" will not be accepted.

**Block 5:** May not be altered through the use of this form.

**Block 6:** The annual report must be signed by a person authorized to represent the LLC. Print or type the name of the signer below the signature.
