# ARTICLES OF INCORPORATION

OF

#### UNITED, INC.

The undersigned, acting as incorporators of a corporation the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

NAME. The name of the corporation is, UNITED, INC.

### ARTICLE II

DURATION. The period of its duration is perpetual.

#### ARTICLE III

PURPOSE. The purpose for which the corporation is organized is:

- To manufacture, buy, sell, import, export, and otherwise deal in furnishings of wood, metal, or synthetic material, 14 for general use in homes and offices; to manufacture, buy, sell, or otherwise deal in component parts and materials of every nature and description for use in such furniture; and to develop, construct, and patent or otherwise protect, new designs in home and office 16 furnishings.
- 2. To engage in the transaction of any and all other lawful business for which corporations may be incorporated under the pro-18 visions of Chapter I, Title 30 of the Idaho Code or any amendments or supplements thereto.

# ARTICLE IV

The STOCK. aggregate number of shares which corporation shall have authority to issue is 2,500. Said stock shall be of one class designated as common stock with a par value of \$10.00 22 per share.

## ARTICLE V

REGISTERED OFFICE AND REGISTERED AGENT. The address of the initial registered office of the corporation is 125 Evans Street, 25 Caldwell, Canyon County, Idaho 83605, and the name of its initial registered agent at such address is, Ron R. Edwards.

## ARTICLE VI

DIRECTORS. The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successor is elected and shall qualify are:
