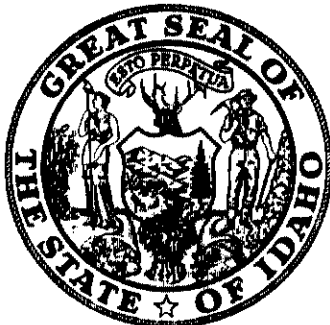
CERTIFICATE OF INCORPORATION OF

I, the undersigned person, having voluntarily associated myself for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles as follows:

ARTICLE ONE

Name

The name of the corporation is Translators, Inc.

The duration of the corporation is perpetual.

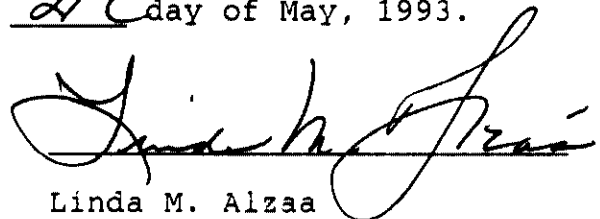

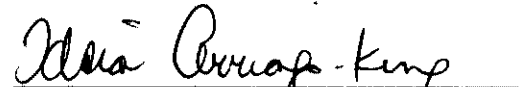
