ARTICLES OF INCORPORATION

OF

G. H. BROWN CONSTRUCTION, INC.
A California Corporation

I

The name of this corporation is: G. H. BROWN
CONSTRUCTION, INC.

II

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III

This corporation is authorized to issue only one class of shares of stock; the total number of said shares shall be one thousand (1,000).

IV

The preferences privileges and restrictions granted to or imposed upon the holders of the respective shares of this corporation are as follows:

Each shareholder or subscriber to shares of this corporation shall be entitled to full preemptive

or preferential rights, as such rights have been heretofore defined at common law. Each shareholder of this corporation shall be entitled to purchase and/or subscribe for the number of any shares of this corporation, which may be issued for money, which bears the same ratio to the number of shares subscribed or outstanding immediately prior to such additional issue.
