

incorporator The undersigned, acting as corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST

The name of the corporation is BOISE CITY OF TREES FESTIVAL, INC.

SECOND

The corporation is a nonprofit corporation

THIRD

The period of its duration is perpetual.

FOURTH

This corporation is organized exclusively for the promotion of the social welfare of the people of the City of Boise, State of Idaho by such activities as permitted to be carried on by any organization exempt from Federal income tax under section 501(c)(4) of the Internal Revenue Code or the corresponding sections of any future Federal tax code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(4) of the Internal Revenue Code or the corresponding sections of any future Federal tax code.

FIFTH

The corporation shall have members. SIXTH

The location of the initial registered office of the corporation is 300 North Sixth Street, Boise, Idaho 83702, and the name of its initial registered agent at such address is Dale G. Higer.

NINTH

The Board of Directors is expressly authorized to alter, amend or repeal the bylaws of the corporation and to adopt new bylaws.

TENTH

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Fourth hereof.

ELEVENTH

dissolution of this and winding up corporation, after paying or adequately providing for debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for the promotion of social welfare and which has established its tax exempt status under 501(c)(4) of the Internal Revenue Code or the corresponding sections of any future Federal tax code.
