The undersigned, for the purpose of restating the Articles of Incorporation for File #: 0004102524 n under the provisions of the Idaho Nonprofit Corporations Act (Chapter 30 Title 30, Idaho Code), hereby certify that the following Restated Articles of Incorporation. ARTICLE 1. NAME

The name of this corporation is “**THE GENESEE COMMUNITY CHURCH, INC.**”

ARTICLE 2. DURATION

The period of existence of this corporation shall be perpetual.

ARTICLE 3. EFFECTIVE DATE

Effective upon filing.

ARTICLE 4. PURPOSE

This is a religious, non profit corporation. The purpose of this corporation is to establish and maintain a Community Church and to provide a place or places of worship for the same in the City of Genesee, County of Latah, State of Idaho; to establish, maintain, and conduct schools for religious instruction of the young, and to further other religious and charitable work, at to that end may adopt and establish by-laws, make all rules and regulations deemed necessary and expedient for the management of its affairs, in accordance with law and not inconsistent with these articles of incorporation.

ARTICLE 5. PRINCIPLE PLACE OF BUSINESS

The principal place of business of this corporation shall be the City of Genesee in Latah County, State of Idaho.

ARTICLE 6. VOTING MEMBERS

The corporation has voting members. The organization and voting are governed by Idaho law, these Articles of Incorporation and the Amended By-Laws of the corporation.

ARTICLE 7. POWERS

In general, and subject to such limitations and conditions which are or may be prescribed by law, or in **THE GENESEE COMMUNITY CHURCH, INC.’S** Articles of Incorporation or Amended By-laws, **THE GENESEE COMMUNITY CHURCH, INC.** shall have all powers which now or are hereafter conferred by law upon a corporation organized for the purpose hereinabove set forth, or necessary or incidental to the powers so conferred, or conducive to the attainment of the purpose of the corporation.

ARTICLE 8. DIRECTORS

The affairs of **THE GENESEE COMMUNITY CHURCH, INC.** shall be governed by a Board of Directors. The number of directors, their qualifications and terms of office, the manner in which they are selected and may be removed from office, the rules and procedures regarding their meetings, and their powers and duties shall be as from time to time prescribed in the Amended By-laws of the corporation.

ARTICLE 9. AMENDMENTS TO ARTICLES OF INCORPORATION

The Articles of Incorporation of **THE GENESEE COMMUNITY CHURCH, INC.** may be amended, altered, or repealed pursuant to the Amended By-Laws of the corporation.

ARTICLE 10. BY-LAWS

The power and authority to adopt, amend and repeal the Bylaws of **THE GENESEE COMMUNITY CHURCH, INC.** is governed by the Amended By-Laws of the corporation. The Amended By-laws may contain any provision for the regulation and management of the affairs of **THE GENESEE COMMUNITY CHURCH, INC.** which is not inconsistent with these Articles of Incorporation or the laws of the State of Idaho.

ARTICLE 11. ORGANIZATION

THE GENESEE COMMUNITY CHURCH, INC. is organized exclusively for charitable, religious and educational purposes.

ARTICLE 12. DISSOLUTION

Upon dissolution, the assets of **THE GENESEE COMMUNITY CHURCH, INC.** shall be distributed pursuant to direction of the Board of Directors of the corporation.

ARTICLE 13. CERTIFICATE OF ADOPTION

The undersigned, in order to restate its Articles of Incorporation as a Non-Profit Corporation under the provisions of Title 30, Chapter 30, Idaho Code, submitted its CERTIFICATE OF ADOPTION OF RESTATED ARTICLES OF INCORPORATION to the Secretary of State of the State of Idaho on OCTOBER 11, 2020.
