The undersigned, a person of the age of more than eighteen years, acting as the incorporator of the above corporation, hereby signs and acknowledges the Articles of Incorporation and does declare and set forth as follows:

ARTICLE I.

The name of the corporation shall be WILD RIVER CONSTRUCTION, INC..

ARTICLE II.

The duration of the corporation shall be perpetual.

ARTICLE III.

The purposes for which the corporation is formed are:

1. The purpose or purposes for which this corporation is organized is for general home construction and the transaction of any and all lawful business for which a corporation may be incorporated under the Idaho Business Act.

2. To carry on the primary business in which the corporation intends to initially engage; to employ any and all persons necessary for the purpose of or in connection with any aspect of the business.

3. To acquire by purchase, subscription or otherwise, and to hold for investment or otherwise, and to use, sell, assign, transfer, mortgage, pledge or otherwise deal with or dispose of stocks, bonds, or any obligations or securities of any corporation in such manner as may be provided by law.

4. To borrow money and to make and issue notes, bonds, debentures, obligations and evidence of indebtedness of all kinds, whether secure by mortgage, pledge or otherwise without limit as to amount, except as may be prohibited by statute and to secure the same by mortgage, pledge or otherwise and generally to make and perform agreements and contract of every kind and description.

The authorized capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00) consisting of fifty thousand (50,000) shares of common stock at \$1.00 par value.

ARTICLE V.

The capital stock of this corporation shall be one class only, and all shares shall have equal rights and voting powers and there shall be no preference.

ARTICLE VI.

No shareholder shall the preemptive right to acquire unissued shares of the corporations stock.

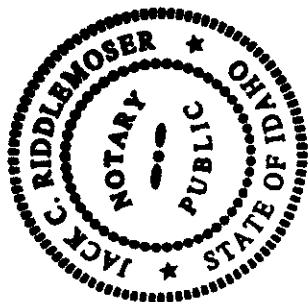


