

ARTICLES OF INCOMPORATION

OF.

DEB'S RESTAURANTS, INC.



COMPORATION WALTER D. HEMLEY, whose names are hereunto subscribed, do hereby associate ourselves together for the purpose of forming a Corporation under the laws of the State of Oregon;

And we do hereby certify that:

ARTICLE I

The name of the Corporation shall be DEB'S RESTAURANTS, INC., and its duration shall be perpetual.

ARTICLE II

The purposes for which said Corporation is formed, including the specific enterprises, pursuits and occupations in which the Corporation proposes to engage itself are as follows:

- (1) The specific business in which the Corporation intends to primarily and initially engage is owning and operating restaurants and lounges within the United States of America, its territories and foreign countries, and for the purpose of owning, holding and operating, leasing, selling dealing in, contracting for real and personal properties of all kinds, nature and description which may be used directly or indirectly in connection therewith.
- (2) To do and to perform any other act, matter or thing necessary, proper or convenient for the accomplishment or carrying out of the enterprises, husinesses, pursuits and occupations hereinahove specified or any other business in connection with the foregoing, and to have and to exercise any and all of the powers conferred by the laws of the State of Oregon upon Corporations, and to do any and all of the things hereinabove set forth to the same extent as natural persons night or could do.
- (3) The foregoing clauses shall be construed both as purposes and powers, and it is expressly provided that the foregoing enumeration

ARTICLE ITI
