

ARTICLES OF INCORPORATION
OF

O·I PUBLISHING, INC.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is O·I PUBLISHING, INC. and its duration shall be perpetual.

ARTICLE II

The object of this corporation is to engage in general business and to manufacture, purchase or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with goods, wares, merchandise and real and personal property of every class and description.

ARTICLE III

The aggregate number of shares which the corporation shall have authority to issue is 100 shares at no par value per share.

ARTICLE IV

The corporation will not commence business until \$1,000.00 has been received by it as consideration for the issuance of its stock.

ARTICLE V
