ARTÍCLES OF INCORPORATION

of

REINKE FARMS CO.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being citizens of the United States, and of full age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify in writing:

I.

That the name of said corporation shall be REINKE FARMS CO

That the purposes for which said corporation is formed are:

- (1) To conduct a general farming and livestock business and in that regard: To acquire and own, operate, improve, and develop farms, agricultural lands, grazing lands, and rights therein; to lease and operate farms, agricultural lands, grazing lands and rights therein and to deal and trade in farms, agricultural lands, grazing lands and rights therein; to deal and trade in farm products and by-products; to deal and trade in, and to own and manage livestock; and to deal and trade in livestock products and by-products.
- (2) To conduct any other kind of business activity that the Board of Directors may, from time to time, by resolution determine to be advisable for the corporation to conduct in relation to a general livestock and farming business.
- (3) To purchase its own stock for the following purposes: to reorganize its capital structure; to enter such stock upon its books as treasury stock; to reissue such stock; to redeem such stock; and to deal and trade in such stock.

(4) To act as surety and guarantor in any and all types of engagements including the power to execute, endorse and deliver contracts, and to guarantee the prompt and faithful performance and payment of debts, notes, agreements, contracts and undertakings of any other person, firm, partnership, or corporation; and including also the power to act as an accomodation co-maker or guarantor of obligations either as a primary or secondary obligor.

(5) None of the purposes enumerated herein shall be a limitation on the powers and authorities granted to corporations by the laws and statutes of the State of Idaho, all of which powers are expressly claimed by this corporation.

III.

That the term for which said corporation shall exist is perpetual.

IV.

That the number of directors of said corporation shall be fixed by the By-Laws of the corporation, except that such number shall be not less than three (3) nor more than seven (7).

V.

That the registered office of said corporation in the State of Idaho shall be located at Twin Falls, in the County of Twin Falls, and that the post office address of the registered office of said corporation shall be c/o S. S. Reinke, R. F. D. #3, Twin Falls, Idaho.

VI.

The capital stock of the corporation shall be composed entirely of stock of no-par value and the authorized number of such shares of no-par value stock shall be two hundred fifty (250).

VII.

That the amount of capital stock of said corporation which has been actually subscribed is three (3) shares, and the following are the
