# ARTICLES OF INCOMPORATION

OF

### KEY ENVIRONMENTAL SERVICES OF IDAHO INC.

We, the undersigned, natural persons of the age of twenty-one years or more, acting as incorporators under the Idaho General Business Corporations Act, adopt the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of this Corporation is Key Environmental Services of Idaho, Inc.

#### ARTICLE II - SHARES

The aggregate number of shares which this Corporation shall have the authority to issue is 5,000 shares at \$1 par. All stock of the Corporation shall be of the same class, common, and shall have the same rights, voting power and preferences and be subject to the same restrictions. The Board of Directors or the Shareholders may adopt by-laws restraining the alienation of shares and providing for the purchase or redemption by the Corporation of its shares.

#### ARTICLE III - DURATION

The duration of this Corporation is perpetual.

# ARTICLE IV - PURPOSE

The nature of the business or purposes to be conducted or promoted are toxic waste remediation work and any other lawful

act or activity for which profit corporations may be organized under the laws of Idaho.

#### ARTICLE V - PREEMPTIVE RIGHTS

The Shareholders shall have preemptive rights to acquire additional shares of the Corporation.

## ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

If the fact of such relationship or interest is known then the common or interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes, approves, or ratifies such contract or transaction.
