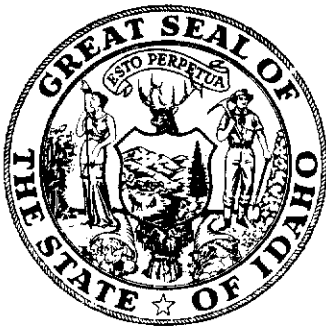



1. The name of this Corporation is Sawtooth Equipment, Inc.
2. The period of duration for this corporation shall be perpetual.
3. The purpose for which this Corporation is organized is the transaction of any or all lawful business for which Corporations may be incorporated under the Idaho Corporations Code.
4. This Corporation is a Professional Corporation within the meaning of the Idaho Corporations Code.


