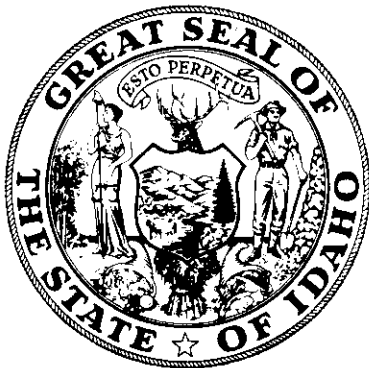

KNOW ALL MEN BY THESE PRESENTS:

1. The name of this corporation, a corporation for profit, shall be Rocky Mountain Reforestation, Inc.

2. This corporation shall have perpetual duration.

3. This corporation is organized for the purpose of transacting any lawful business, including, but not limited to, the planting of trees and related work for governmental and private interests.

4. This corporation shall be authorized to issue 1000 shares of stock of a single class with par value of \$.10 (ten cents) per share for an authorized capital stock of \$100.00.
