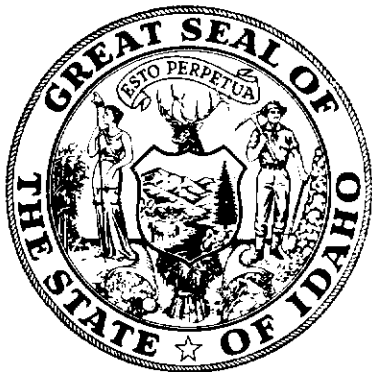

1 RESTATED  
2 ARTICLES OF INCORPORATION

3 OF

4 POST FALLS CHAMBER OF COMMERCE, INC.

5 Pursuant to the provisions of Section. 30-1-64 of the  
6 Idaho Business Corporation Act, the undersigned corporation,  
7 pursuant to a resolution duly adopted by its board of directors,  
8 hereby adopts the following Restated Articles of Incorporation:

9 KNOW ALL MEN BY THESE PRESENTS, that we, the under-  
10 signed, all of whom are of legal age and citizens of the  
11 United States, have this day voluntarily associated ourselves  
12 and do hereby, and by these Articles of Incorporation, unite  
13 and associate ourselves for the purpose of forming a nonprofit  
14 corporation under and pursuant to the provisions of Chapter 11,  
15 Title 30, of the Idaho Code, and we hereby acknowledge, enter  
16 into, and adopt the following Articles of Incorporation.

17 ARTICLE I.

18 The name of this corporation shall be Post Falls  
19 Chamber of Commerce, Inc.

20 ARTICLE II.

21 The period of the duration of this corporation shall  
22 be perpetual.

23 ARTICLE III.

3 ARTICLE IV.

4 In furtherance, and not in limitation of the general  
5 powers conferred by the laws of the State of Idaho, this  
6 corporation shall have the following objects, purposes and  
7 powers:

- 8 1. To advance the educational, civic, social,  
9 commercial and economic interests of the  
10 village of Post Falls, Kootenai County,  
11 Idaho, and the general welfare and pros-  
12 perity of its tributary territory; to  
13 promote integrity and good faith, just  
14 and equitable principles in business and  
15 professional activity, and uniformity in  
16 commercial usages, and to acquire,  
17 preserve and distribute educational,  
18 civic, social, commercial and economic  
19 statistics and information of values;  
20 to discover and correct abuses, to  
21 prevent or adjust controversies; to have  
22 a part as representing the said village  
23 in the consideration and decision of  
24 public policy in municipal, county,  
state and national affairs.
2. To provide a suitable place for the  
meeting of its members, the establishment  
of facilities for educational, civic,  
social, commercial, economic and political  
research, including social and recreational  
features, so as to sustain interests of  
its members and secure intelligent action  
on the part of its boards and committees  
in the accomplishment of its general  
purpose.
3. To acquire, dispose of, or otherwise operate,  
maintain and control any and all types of  
property or interests therein, necessary for  
the business and objects of this corporation.

16 That notice of the time and place of holding the  
17 election as herein set forth, was given by publication for two  
18 (2) weeks in the Post Falls Tribune, Post Falls, Idaho, and a  
19 notice of the election was posted for the same length of time  
20 on the building where the election was held.

21 The foregoing restated articles of incorporation  
22 correctly set forth without change the corresponding provisions  
23 of the articles of incorporation as heretofore amended, and  
24 supersede the original articles of incorporation and all

1 amendments thereto.
