

Trustees, are over the age of 21 and citizens of the United States and of the State of Idaho, being the designated and authorized persons, do hereby execute and acknowledge these articles of Incorporation of the Conservative Baptist Church of Weiser, Idaho as follows:

#### ARTICLE I - NAME

The name of this organization, a corporation shall be the CONSERVATIVE BAPTIST CHURCH OF WEISER, IDAHO, INC.

#### ARTICLE II - PURPOSE

The purpose of this Church shall be:

- 1. Provide worship services where the Word of God is taught and preached.
- 2. Provide a Christian Education program through the establishment of a Sunday School, Youth Meetings, Home Bible Classes, Vacation Bible School, Camping Program, Bible Institute and a Christian Day School as we are enabled and directed by the Lord.
- 3. Help in the spreading of the gospel of the Lord Jesus Christ to the uttermost parts of the earth.
- 4. Help in meeting the needs of the poor and aged as the Lord directs and provides.

### ARTICLE III - MEMBERSHIP

The membership of this church shall consist of believers in the Lord Jesus Christ who have been immersed; and acknowledge substantial agreement with the faith and

## ARTICLE IV - OFFICERS

The Scriptural officers of this Church are: Pastor and Deacons, and the by-laws shall determine their election, term of office and succession. The Trustees shall be chosen from among the Deacons and shall not be less than three in number or less than one-third of the total number of Deacons. They shall serve a term of one year. They shall be elected from among the Deacons at the Annual Business Meeting held in January of each year. Only active members as set forth in the constitution, shall have the right to vote. The initial Board of Trustees shall serve from the time of this meeting until the first annual meeting in January of 1965.

## ARTICLE V - STATEMENT OF FAITH

- 1. We believe that the Bible is God's Word, that it was written by men Divinely inspired and that it is the supreme infallible authority in all matters of faith and conduct.
- 2. We believe in God the Father, perfect in holiness, infinite in wisdom, measuraless in power. We rejoice that He concerns Himself mercifully with the affairs of men, that He hears and answers prayer, and that He saves from sin and death all that comes to Him through Jesus Christ.
- 3. We believe in Jesus Christ, the eternal and only begotten Son of God, conceived of the Holy Spirit, of virgin birth, sinless in His life, making atonement for the sins of the world by His death. We believe in His bodily resurrection, His ascension and visible, pre-millennial return to the world according to His promise.
- 4. We believe in the Holy Spirit who came forth from God to convict the world of sin, of righteousness and of judgment, and to regenerate, sanctify and comfort those who believe in Jesus Christ.
- 5. We believe that all men by nature and by choice are sinners but that "God so loved the world that He gave His only begotten Son that whosoever believeth in Him should not perish but have everlasting life", we believe, therefore, that those who accept Christ as Lord and Saviour will rejoice forever in God's presence and those who refuse to accept Christ as Lord and Saviour will be forever separated from God.

- 6. We believe in the Church—a living spiritual body of which Christ is the head and of which all regenerated people are members. We believe that the local church is a company of believers in Jesus Christ, immersed on a credible confession of faith, and associated for worship, work and fellowship. We believe that to these local churches were committed, for perpetual observance, the ordinances of baptism and the Lord's supper, and that God has laid upon these churches the task of preclaiming to a lost world the acceptance of Jesus Christ as Saviour, and the enthroning of Him as Lord and Master. We believe that all human betterment and social improvements are the inevitable by products of such a Gospel.
- 7. We believe that every human being is responsible to God alone in all matters of faith; that each church is independent and autonomous and must be free from interference by any ecclesiastical or political authority; that therefore Church and State must be kept separate as having different functions, each fulfilling its duties free from the dictation or patronage of the other.

#### ARTICLE VI - POWERS OF CORPORATION

The trustees shall have no power to buy, sell, mortgage, lease or otherwise transfer or encumber property of the Church without first receiving authority from the congregation of the Church to do so, after a meeting of the congregation has been regularly called for such purpose according to the duly enacted by-laws of this corporation and a two-third (2/3) majority vote of those members present having voted in the affirmative to so instruct the trustees. Nor shall the trustees have exclusive control over the use of the Church and the church property until said trustees have been instructed by a majority vote of the members of the congregation as aforesaid.

The powers of this Corporation shall include, but not be limited to the following:

- 1. To purchase, own and convey property.
- 2. To mortgage and to loan money.
- 3. To purchase and use all that is necessary for church life and operation in the pursuing of the aforementioned purposes.
- 4. To hire and bond personel necessary for the accomplishing of the purposes of this Corporation.

5. Such other powers permitted or granted by law, which are in keeping with, or in aid of, the general purposes of the Corporation.

### ARTICLE VII - LOCATION

This Corporation shall be located in Washington County, and the Post Office address shall be Weiser, Idaho. The duration of this corporation shall be perpetual. In case of dissolution all properties shall be conveyed to the Conservative Baptist Association of Idaho.

## ARTICLE VIII - AMENDMENTS

These Articles of Incorporation may be amended by a majority vote of a quorum of active members present and voting at any business meeting provided such amendments have been submitted in writing at a previous meeting held not less than one month before the time of voting. A public notice of the intention to amend the Articles of Incorporation shall have been given by publication at least once a week for four weeks in the local newspaper.
