1. Thomas J. Devine, being presently a limited partner and having contributed the sum of \$12,500.00 to the Partnership as a limited partner, has agreed to make additional contributions to the Partnership to the extent necessary to satisfy any debt owing by the Partnership to the Lincoln First Bank of Rochester which remains unpaid after all other assets of the Partnership have been applied to the payment of the secured debts of the Partnership, which additional contributions shall be limited to the maximum amount of \$900,000.00 and shall be senior and preferred to all other capital contributions to the Partnership.
