I FURTHER CERTIFY, That the persons executing the articles and their associates and
successors are hereby constituted a corporation, by the name hereinbefore stated, for **Twenty-five**
years from the date hereof, with its registered office in this State located at

and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative
Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION.

We the undersigned citizens of the United States of America, each over the age of twenty-one years and parties hereto for the objects and purposes hereinafter stated, in order to form an association pursuant to the laws of the State of Idaho, do hereby associate ourselves together and certify as follows:

I.

NAME.

That the name of this corporation or association is and shall be "TOPPER AMUSEMENT CLUB, INC."

II.

OBJECT.

The objects and purposes for which this corporation or association is formed are for the recreation, amusement, entertainment and social and mutual benefit of its members.

III.

PLACE OF BUSINESS.

The principal place of business of this corporation or association is Jerome County, State of Idaho, with its Post Office address Jerome in said County and State.

IV.

TERM OF EXISTENCE.

The term for which this corporation is to exist is Twenty-five (25) years from and after the date of the certificate of incorporation issued by the Secretary of State of the State of Idaho for its incorporation.

V.

The number of directors of this corporation shall be three and the following named persons shall be the directors for the first year of the existence of this association or

corporation and until their successors are elected, to-wit:

NON-PROFIT.

BY-LAWS.

This association or corporation shall adopt a set of by-laws in conformity with the laws of the State of Idaho, immediately upon the issuance, by the Secretary of State of the State of Idaho of a Certificate of Incorporation to it and the organization of its board of directors.
