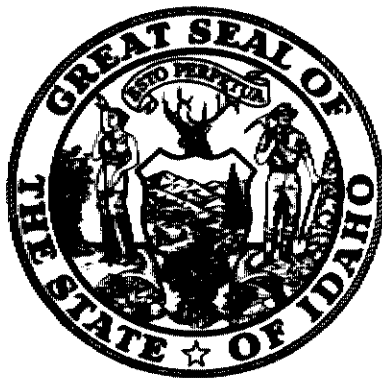
**CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Aspenbreak Stables, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized are: Operation of an indoor-outdoor equine boarding facility, and any and all activities related thereto and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, all of one class at \$0 par value.

FIFTH: The address of the initial registered office of the corporation is Rt. 3, 330 N. Eagle Rd., Kuna, Idaho 83634, and the name of its initial registered agent at such address is Karen J. Vehlow, Secretary-Treasurer.
