This Plan of Conversion (this "Plan") is adopted in accordance with California Corporate Code Sections 16902(a) and 16903(a) and Idaho Code Sections 30-22-401(b), 30-22-403(b), and 30-22-405(a)-(f).

- 1. Kroes Investment Company is a California general partnership organized under the California Uniform Partnership Act of 1994.
- 2. Kroes Investment Company, LLC is an Idaho limited liability company hereby organized under the Idaho Uniform Limited Liability Act.
- 3. This Plan shall be effective as of the first day of the first calendar month following the filing of this Plan with the Idaho Secretary of State (the "Effective Date").
- 4. This Plan is hereby approved and adopted by (a) all of the partners of Kroes Investment company in accordance with the law of California, and (b) all of the members of Kroes Investment Company, LLC in accordance with the law of Idaho.
- 5. Attached hereto is the Certificate of Organization for Kroes Investment Company, LLC.
- 6. As of the Effective Date, the 20% partnership interest of each general partner in Kroes Investment Company shall be and is hereby converted without further writing into an equivalent 20% membership interest in Kroes Investment Company, LLC.
- 7. The members of Kroes Investment Company, LLC are bound by, and their rights and obligations arise under, (a) the attached Certificate of Organization Limited Liability Company, and (b) the Operating Agreement of Kroes Investment Company, LLC, in the form heretofore executed by all of the members.
- 8. This Plan may be executed and delivered (including by facsimile or portable document format (pdf) transmission) in counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument.
