**ARTICLES OF INCORPORATION**  
**OF**

Pursuant to the provisions of Section 30-1-1007 of the Idaho Business Corporation Act, Pulent Pest Control, Inc. has adopted these Articles of Incorporation, as follows:

**Name.** The name of the corporation is Pulent Pest Control, Inc.

**Authorized shares.** The aggregate number of shares the corporation is authorized to issue shall be one thousand (1,000) shares, all of which shall be common voting stock.

**Registered office and agent.** The registered office of the corporation is 3724 Plantation River Dr., Suite 101, Boise, Idaho 83703 and its registered agent at that address is Joel A. Flake, Jr.

**Corporate purpose.** The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**Board of Directors.** All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of, its board of directors, subject to any limitation set forth in a shareholder agreement authorized under Idaho Code Section 30-1-732. The number of directors constituting the board of directors may range between two (2) and six (6) and may be fixed from time to time in accordance with the bylaws; provided, however, that there shall not be fewer than two (2) directors. **Section 6.1 Corporation By-Laws.** The Board of Directors is authorized and empowered to make, alter, amend, and rescind the By-Laws of the corporation.

**Section 7.1 Indemnification.** The corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader

indemnification than the Idaho Business Corporation Act permitted the corporation to provide prior to such amendment).

**Section 8.1 Limitation of Liability.** Pursuant to the General Corporation Laws of the State of Idaho, any and all directors of this Corporation shall not be liable to the Corporation, its shareholders, or any third party for breach of duty of care; such potential liability is hereby eliminated.
