ARTICLES OF INCORPORATION
OF
CAPITOL HOLDINGS, INC.

We, the undersigned natural persons all over the age of twenty-one years and citizens of the United States acting as incorporators under the Idaho Corporation Laws, adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is CAPITOL HOLDINGS, INC. its duration shall be perpetual.

ARTICLE II.

This corporation may engage in any commercial, industrial financial and agricultural enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho; further, in pursuance of such corporation purpose, this corporation may manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, lease, assign, and transfer or otherwise dispose of, invest, trade, transport and deal with, goods, wares, services, and merchandise and real and personal property of every class and description.

In general and in connective with the foregoing, said corporation shall have and exercise all of the powers conferred under the laws of the State of Idaho, upon business corporations, and each and everything necessary, suitable or advisable for the accomplishment of the foregoing objects, or which at any time appear to be conclusive to or expedient for the benefit of said corporation in connection therewith.

ARTICLE III.

The location and Post Office address of the registered office of this corporation in the State of Idaho is 1017 Jefferson Street, Boise, Idaho.

ARTICLE IV.

The total authorized number of shares which the corporation

shall have the authority to issue is One Hundred (100) shares consisting of common voting stock only and the par value of each share shall be (\$50.00), making an aggregate par value of \$5,000.00.




ARTICLE VI.
