ARTICLES OF INCORPORATION

The undersigned, being over eighteen years of age and citizens of Idaho, hereby organize the following nonprofit rural cemetery association, as provided in Idaho Code, § 27-201, et seq.

FIRST: The name of the association, is Brinkwood Cemetery Association, Inc.

SECOND: The period of duration is perpetual.

THIRD: The purpose is to acquire, operate and maintain a rural cemetery on a portion of the original Brinkwood homestead property at Sunnyside, Bonner County, Idaho, and to make the same available to descendents and families of descendents of said Brinkwoods and to conduct all other business relevant or useful thereto.

FOURTH: The original registered agent is Dalton A. Hawkins, 8264 Sunnyside Road, Sandpoint, ID 83864. Such address is also that of the initial registered office of the association.

FIFTH: The affairs of the association shall be governed by a board of directors of not less than three (3) nor more than fifteen (15), as the bylaws provide. Officers shall be a president, vice president, secretary, and treasurer, or a secretary-treasurer, all of whom shall hold office for one year and until the election and qualification of the successors. Vacancies in the board or in the offices shall be filled by the board of directors.

Initially, the association shall have three (3) directors and the following individuals shall serve as such until their successors are appointed and approved:

SIXTH: The associations shall not have authority to issue shares of stock, provided however that every person who acquires a lot or lots shall become a member and shall have one vote. Meetings of the members shall be held at least annually at such time and place and upon such notice as may be prescribed in the bylaws.
