States, for the purpose of forming a corporation pursuant to the

do hereby certify as follows:

FIRST

The name of the corporation is

SECOND

The corporation is to have perpetual existence.

THIRD

The purposes and objects for which the corporation is organized



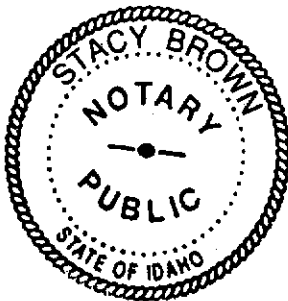
