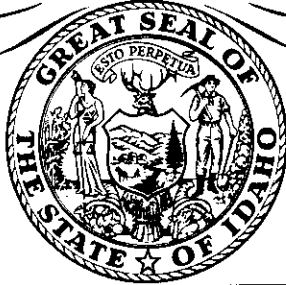

ARTICLES OF INCORPORATION

of

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, natural persons of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

We do hereby certify --

I

That the name of the corporation is LYNN JOSEPHSON PRODUCE, Inc. ;

II

That the duration of this corporation is perpetual;

III

That the place of business of this corporation and home office location is 405 North 8th Street, Payette, Idaho;

IV

That the purposes for which this corporation is formed are:

To engage in the business of buying, selling, storing, processing and shipping of vegetable products;

To buy, sell, mortgage and hypothecate any and all real and personal property;

To deal in any and all stocks, bonds, notes, and other debentures or evidence of debt;

To engage in any lawful activity for which corporations may be organized under Idaho Code Title 30 Chapter 1 Section 14.

The total authorized common capital stock of this corporation shall be Two Hundred Fifty Thousand Dollars (\$250,000.00), consisting of 10,000 shares

of common capital stock of the par value of \$25.00 per share.






All or any meetings of the Board of Directors may be held with or without the State of Idaho.


