AMENDMENT TO ARTICLES OF INCORPORATION

0F

CLEVELAND SOUND AND COMMUNICATIONS, INC.

BE IT KNOWN BY THESE PRESENTS, That all of the shareholders of the above corporation have given their written consent that the Articles of Incorporation of this corporation may be amended and changed to read as follows:

ARTICLE I

That the name of this corporation shall be Executone -Central Idaho, Inc.

ARTICLE II

The purposes for which this corporation is formed are:

- To buy, sell, install, manufacture, process, import, export or otherwise deal in electronic or other equipment, finished products or raw materials, for itself or on contract for other persons, companies or organizations, and for any other lawful purpose.
- To act as distributor for Executone Products and to sell, install and service communication and signaling systems and other devices bearing the trade mark or name "Executone" or such other trade mark or name of which "Executone" may be a part.
- To borrow money, contract debts, make contracts, and to exercise any and all such powers as a natural person could lawfully make, do, perform or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the State of Idaho and to that end, enumeration of such powers shall not be deemed inclusive.

In all other respects, the Articles of Incorporation of this corporation shall remain the same.
