ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

FREEDOM EDUCATION SERVICE, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, P. R. Bakes, the duly elected and acting Chairman, and H. L. Day, the duly elected and acting Secretary of a special meeting of the members of Freedom Education Service, Inc., a non-profit cooperative association, organized and existing under the laws of the State of Idaho, which was held in the office of the association in the Scott Building, in the City of Wallace, Idaho, at the hour of 1:30 P.M. (MST) on the 4th day of January, 1967, do hereby certify:

That by a resolution duly adopted, the proper officers of the association were directed to execute and file with the Office of Secretary of State of Idaho, Annual Corporate Statement in order that the association might be reinstated.

Said special meeting also was called for the purpose of amending the Articles of Incorporation by adding thereto a new Article VII, which reads as follows, to-wit:


Upon dissolution of Freedom Education Service, Inc., any and all assets of the said Association shall be transferred to and vest in the Association for the Preservation and Commemoration of the Old Cataldo Mission, Inc., Cataldo, Idaho, a tax exempt organization, and shall not be distributed to its members.


That thereupon the Chairman directed that the ayes and nays be taken on a motion for adoption of said resolution, which motion was unanimously adopted, whereupon the Chairman declared that more than 2/3 of the members having voted in favor of said resolution

and the motion to adopt the same, and that said motion was duly carried and said resolution duly adopted and that said Amendment of the Articles of Incorporation of said Freedom Education Service, Inc. was duly approved.

That thereupon the Chairman directed the Secretary to cause to be prepared proper Articles of Amendment of the Articles of Incorporation of said Freedom Education Service, Inc. to be prepared and executed in triplicate, as required by law, that one executed copy thereof be filed in the Office of the Secretary of State of the State of Idaho and that one of the remaining executed copies, after endorsement by the Secretary of State, be filed then in the Office of the County Recorder of Shoshone County, Idaho, where the principal place of business of said association is located, and that the remaining one of said copies be retained by the Secretary of the corporation, as required by law.

Day, Secretary of said Freedom Education Service, Inc., and Secretary of said meeting, having hereunto set their hands in triplicate this 7<sup>th</sup> day of January, 1967.





