ARTICLES OF INCORPORATION

OF

RIVERDALE WATER SYSTEM, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, Chapter 3, Nonprofit Corporations, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is RIVERDALE WATER SYSTEM, INC.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose for which this corporation is formed shall be and is to own, lease, rent, or otherwise acquire water and water rights, and to distribute such water so acquired among its stockholders for cullinary and other purposes, and to that end and for that purpose to construct, own, lease, or otherwise acquire, and to maintain and operate, flumes, aquaducts, pipeline or other means of distributing and conveying in water; to own, lease or otherwise acquire pumps, motors, engines, and all other necessary equipment incidental to distribution of said water to enter into contracts, to borrow money; and to make and negotiate notes, contracts, bonds or mortgages, as evidence of, and security for money borrowed or loaned, and for the purpose of perpetrating and carrying out the purpose for which this corporation is formed, to buy, lease or otherwise acquire all real and

personal property necessary for such purposes, including stock in other corporations as directed by the By-Laws.

FIFTH: The address of the initial registered office of the corporation is RIVERDALE WATER SYSTEM, INC., c/o Wilford B. Meek, 3659 North 1600 East, Preston, Idaho 83263, and the same of its initial registered agent at such is WILFORD B. MEEK.

SIXTH: Voting shall be based upon a one (1) vote per membership and membership certificates shall be given for each water hook-up or connection.

SEVENTH: The management of the affairs of the corporation shall be vested in its members pursuant to Idaho Code Section 30-314 (c).
