ARTICLES OF INCORPORATION

OF

We, the undersigned, do for the purpose of organizing a private corporation under the laws of the State of Idaho, hereby associate ourselves together for said purpose, and hereby certify Articles of Incorporation as follows, to-wit:

ARTICLE I

The name of this corporation is and shall be Idaho Silver Magnet Mines Co.

ARTICLE II

The purposes for which this corporation is formed are:
To buy, sell, deal in, locate and otherwise acquire, mining claims and grounds, minerals, metals, and all kinds of real and personal property usual and common in carrying on mining operations; and to conduct, operate, sell, hypothecate, or otherwise dispose of same, including stocks and shares of stocks in other corporations; and all of said business to be carried on at such place, or places, within and without the State of Idaho as said corporation may from time to time determine, and in the broadest sense to include the doing and transaction of all business and undertakings usual and common to be carried on, directly or indirectly, and incident to the said main objects aforesaid.

ARTICLE III

The place where the principal business of this corporation is to be transacted is at Wallace, Idaho.

ARTICLE IV

The term for which this corporation is to exist shall be Fifty years from the date hereof.

ARTICLE V

The number of the Directors of this corporation shall be five.
