



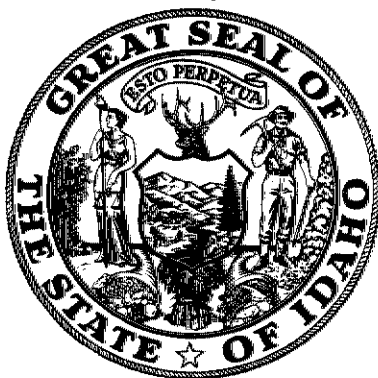
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION OF STATE
OF
I C PRINT, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is I C PRINT, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

1. To engage in the business of copying, printing and graphic production.

2. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) shares of the par value of One Dollar (\$1.00).

FIFTH: The address of the initial registered office of the corporation is 1098 N. Orchard, Boise, Idaho 83706, and the name of its initial registered agent at such address is Peter A. Thompson.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve as the directors until the first annual meeting of shareholders or until the successors are elected and shall qualify are:


