

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ASSOCIATED BUSINESS PRODUCTS OF IDAHO, INC.

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Amendment to the Articles of Incorporation.

FIRST: The name of the corporation is: Associated Business Products of Idaho, Inc.

SECOND: The following amendment to the Articles of Amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on September 7, 1990, in the manner prescribed by Idaho Business Corporation Act:

I.

FIRST of the Articles of Amendment to the Articles of Incorporation of the corporation is amended to read:

"FIRST: The name of the corporation is Associated Business Products, Inc."

THREE. All of the remainder of the Amendment to the Articles of Incorporation shall remain unchanged.

The total number of outstanding shares of the ∞ FOUR. corporation are 157.43 shares of common stock, \$100.00 par value. The total number of authorized of the corporation are 163.10 shares of common stock, \$100.00 par value.

100% of the outstanding shares of the corporation were voted in favor of the amendment. No shares were voted against the amendment.
