## ARTICLES OF FIRST AMERIMAND 17 AM 10 55 TO THE ARTICLES OF INCORPORATION OF SHAVER'S, INC. STATE

Pursuant to the provisions of <u>Idaho Code</u> Section 30-1-61, the undersigned corporation, adopts the following Articles of First Amendment to its Articles of Incorporation received and filed in the Office of the Secretary of State of the State of Idaho, May 18, 1971.

FIRST: The name of the corporation is Shaver's, Inc.

SECOND: The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on the 31 day of January, 1983, in the manner prescribed by the Idaho Business Corporation Act:

## AMENDED PROVISION:

Article V of the Articles of Incorporation is hereby amended and the following supercedes and takes its place:

## ARTICLE V

The amount of the capital stock of the corporation shall be, and is \$4,000,000.00 divided into 200,000 shares with a par value of \$20.00 each and each share of stock shall be nonassessable.

THIRD: The number of shares of the corporation outstanding at the time of the adoption of the amendment was 939. The number of shares entitled to vote on the amendment was 939. All of the

shares of stock of the corporation are of a single class and are common shares.

FOURTH: The number of shares voted for the amendment was 939. No shares were voted against the amendment.

FIFTH: The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

SIXTH: The amendment does not effect a change in the amount of stated capital.
