We, the undersigned, being respectively the President and Secretary of B & G URETHANE, INC., do hereby certify as follows:

- The name of this corporation is "B & G URETHANE, 1. INC.".
- The Articles of Incorporation of said corporation 2. are dated the 5th day of June, 1973, and were duly filed in the office of the Secretary of State of the State of Idaho.
- That pursuant to and in accordance with Section 30-146, subsections (1)(2) of the Idaho Code, at a special meeting 16 duly called for said purpose, the stockholders of the corporation, all of whom were present, voted unanimously to change the name of the corporation to "ED BAILEY, INC.", and a certified copy of the resolution unanimously approved by the shareholders of the corporation is attached hereto as Exhibit "A".
