Ham, Inc. is authorized to issue one class of capital stock identified as "common stock". On September 1, 1966, Di Giorgio Corporation, a Delaware corporation, was the owner and holder of all of the issued shares of common stock of Ham, Inc. and was the only party entitled to notice of a meeting of the shareholders of Ham, Inc. called for the purpose of amending its Articles of Incorporation in the respect herein set forth. On September 1, 1966, by instrument in writing duly signed on behalf of Di Giorgio Corporation, the Articles of Incorporation of Ham, Inc. were amended to change the name thereof to Mountain States Wholesale Company, and, accordingly, paragraph I. of the Articles of Incorporation of Ham, Inc. was thereby amended to read as follows:

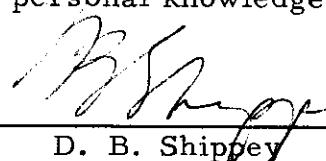

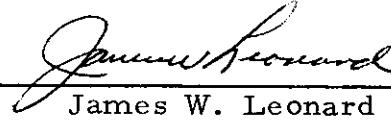
