Pursuant to the provisions of *Idaho Code* 30-1-59, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is *Buhl Implement Co.*

SECOND: Article IV. of the Articles of Incorporation is amended to read:

"Subject to dissolution in the manner provided by law, the corporation shall be perpetual."


THIRD: This amendment was adopted by the shareholders of the corporation at a special meeting held on March 13, 1996.

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was 746.34; and the number of shares entitled to vote thereon was the same. The corporation has only one class of stock.

FIFTH: The number of shares voted for the amendment was 746.34; and the number of shares voted against such amendment was 0.
