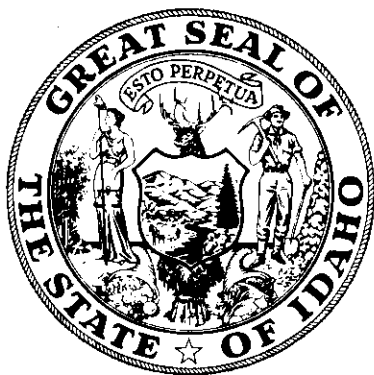

ARTICLES OF INCORPORATION

OF

TRIPLE TREE LOGGING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is TRIPLE TREE LOGGING, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: To log timber, build roads, develop timberlands, and to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1,000) shares of NO PAR VALUE.

ARTICLE V

The address of the initial registered office of the corporation is Route 1, Box 120-C, Cataldo, Idaho 83810, on State Highway 3, one mile south of junction with I-90. The name of its initial registered agent at such address is Paul D. Sverdsten.

ARTICLE VI

The number of directors constituting the initial board of directors of the corporation are three, and the names
