ARTICLES OF INCORPORATION
OF

1. The name of this Corporation is Wild Country Shuttle, Inc.
2. The period of duration for this corporation shall be perpetual.
3. The purpose of this Corporation is to engage in personal and group transportation services and any other lawful activities not prohibited to a corporation by the Idaho Corporations Code.
