

ARTICLES OF INCORPORATION

of the

BOISE RIVER LIGHT AND POWER COMPANY

WE, the undersigned, four of whom are bona fide residents of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the laws of the State of Idaho, do hereby certify as follows:

I

The name of the corporation is "Boise River Light and Power Company"

II

The purposes for which this corporation is formed are: To acquire by purchase, grant or otherwise electricity and electric power for power, heat, light and other purposes and to use, enjoy, sell, dispose, transfer and convey the same; to purchase, lease, bond or otherwise acquire, own, exchange, sell or otherwise dispose of, pledge, mortgage, hypothecate and deal in real estate and all kinds of personal property, and to engage in a general electric lighting and power business, and generally to do all things necessary and proper for the purpose of acquiring and developing electric power for power, heat, light and other purposes; to sue and to be sued, and to adopt and use a corporate seal, and generally to do anything and everything to promote the business of said

corporation, including the borrowing of money for the purposes of said corporation on bonds, notes, bills, acceptances or otherwise under such conditions as the directors of said corporation shall deem for its best interests, and to secure the payment of the same by mortgage upon the property of said corporation or any part thereof.

### III

The principal place of business of this corporation is Boise City, Ada County, State of Idaho.

### IV

The term for which this corporation shall exist is Fifty (50) years.

### V

The number of directors of this corporation shall be Five (5).

### VI

The amount of the capital stock of this corporation is Twenty Five Thousand (\$25,000.00) Dollars, divided into Two Hundred and Fifty (250) shares of the par value of One Hundred (\$100.00) Dollars each.

### VII

The amount of capital stock actually subscribed is Five shares, which is subscribed for by the following named persons, each subscribing for the number of shares set opposite his respective name.
