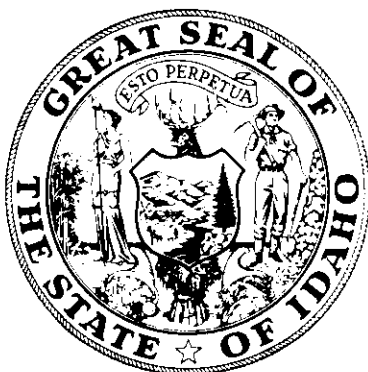

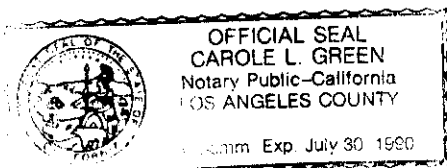

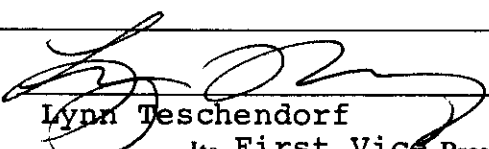
**APPLICATION FOR
