A. H. Jagels and Dwight Johnson, Presiding Officer and Secretary, respectively, of CLOVER TRINITY LUTHERAN CHURCH of Route 1, Buhl, Idaho, formerly Evangelical Lutheran Trinity Congregation of Clover, Idaho, each being first duly sworn on oath, deposes and says: That a regular meeting of the members of said corporation was held at the church house of said organization on April 1, 1951, at 2:00 o'clock P.M.; that there was a quorum attending such meeting; that a majority of said quorum voted in favor of changing the name of said corporation from "Evangelical Lutheran Trinity Congregation of Clover, Idaho" to "Clover Trinity Lutheran Church of Route 1, Buhl, Idaho," and that Article I of the Articles of Incorporation reads as follows, to-wit:

"ARTICLE I.

The name of said corporation is 'Clover Trinity Lutheran Church of Route 1, Buhl, Idaho,'"

and that wherever the name "Evangelical Lutheran Trinity Congregation of Clover, Idaho," appears elsewhere in said Articles of Incorporation, the same shall read "Clover Trinity Lutheran Church of Route 1, Buhl, Idaho".

That before said meeting, notice of intention to vote on the proposition of amending the Articles of Incorporation by changing the name of said corporation, was given by publication in the Times-News, a daily paper published in the County of Twin

Falls, State of Idaho, wherein said meeting was held, in the issue of March 8, 1951, March 15, 1951, March 22, 1951, and March 29, 1951; that the procedure of making the change of name was in accordance with Sections 30-1103 and 30-1105 of the Idaho Code, and in accordance with the Constitution and By-Laws of said organization.
